**resq<sup>®</sup>** products are manufactured with:

- A minimum of 70% post-consumer recycled material sourced from bottles and packaging.
- Our material is suitable for food contact according to FDA regulations.
- We use less natural resources such as water and virgin raw material in their production process.
- They have 40% less carbon footprint during their life cycle than equivalent carton and paperboard packaging.
- They generate 55% fewer emissions than virgin product.
- We use 95% less water in their production than equivalent carton and paperboard packaging.



**resq<sup>®</sup>** makes the circular economy a reality.

In addition, **we reduce the amount of waste that ends up in landfills, or worse, in rivers and oceans.** And best of all, Darnel **resq<sup>®</sup>** products can be recycled over and over again to produce new packaging or other products such as clothes or rugs, thus reducing the amount of virgin raw material extracted from the planet.

Packaging that stand out from the crowd. An innovative design available in various sizes.

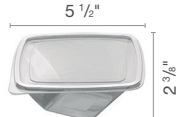

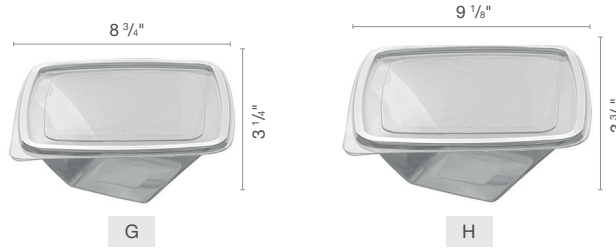
